Dear Shareholder,

**Second and Final Notice – Sale of your unmarketable parcel of Torian Resources Limited Shares**

This notice is the second and final notice to shareholders of Torian Resources Limited (**Company**) who hold unmarketable parcels of shares in the Company.

An unmarketable parcel of shares is defined by ASX Listing Rules as a parcel of shares with a market value of less than \$500.

The first notice that was sent to you, dated 24 December 2015, informed holders of unmarketable parcels (being those shareholders holding less than 2,500 Torian Resources shares) that the Company had arranged for the sale of unmarketable parcels of shares on behalf of those shareholders pursuant to the terms of the Company's Constitution.

As a holder of an unmarketable parcel as at the close of business on 22 December 2015, you were advised that:

- **if you want to sell your shares under the share sale facility** – you do not need to do anything; and
- **if you want to retain your shares** – you must return the Notice of Retention of Shares Form that was attached to the first notice by no later than 5:00pm (WST) on 4 February 2015. A copy of the Notice is also attached to this letter.

As at the date of this second and final notice, the Company's share registry has not received a completed Notice of Retention of Shares Form in respect of your unmarketable parcel.

This letter provides written notice to you that the Company intends to sell your unmarketable parcels unless you sign and return the Notice of Retention of Shares Form to the Company by 5:00pm (WST) on 4 February 2015.
